COMPLAINT OF ABUSE OF OFFICE, CRIMINAL CONSPIRACY, BIAS INVESTIGATION, PROCUREMENT OF CONCOCTED VICTITIOUS POLICE INVESTIGATION REPORT BY SP KOLAJO OGUNDILE, ACP IBRAHIM MUSA OF IGP MONITORING UNIT AND CSP MUYIWA ADEJOBI TO INDICT AND MALICIOUSLY PROSECUTE HON. SAHEED AUDULLAHI MOSADOLUWA AND MRS. FOLASADE BALOGUN (MUMMY AMEN) AT THE INSTANCE AND INSTIGATION OF ONE ADEYINKA IGBINNOBA SPONSORED BY BAPTUNDE OLALERE GBADAMOSI (BOG).

The above subject refers.

We are Solicitors to Hon. Saheed Audullahi Mosadoluwa (hereinafter referred to as our Client) on whose firm instruction we write your Good Offices.

Sir, the above mentioned subject matter had been being a plot since last year carefully orchestrated by one Babatunde Olalere Gbadamosi (BOG) who is an ex-husband to Ms. Folasade Balogun (Mummy Amen): The CEO of Redbrick Homes and International Limited popularly called Amen Estate and a former associate of our client Hon. Saheed Audullahi Mosadoluwa. The bitter separation of the said BOG and Mummy Amen cost the said BOG to lose his relevance as Chairman and he therefore became a redundant Director at Redbrick Homes International Limited as a result of which he is determined

to forcefully take-Over and hijack the whole company and properties belonging to it by keeping the said owner Mummy Amen in the Police cell to languish.

In the build-up to the above, he tried every available opportunity to plant implicating evidence and exhibits in the said Amen Estate but all effort to use our client to achieve such heinous goal was met with fruitless result as our client turned down his mouth watery offer of over ten houses within the Estate. Hence, our client became the second enemy to be hunted down to achieve his goal.

Unknown to our client and Mummy Amen that, he had planned with a lady known as Adeyinak Igbinnoba to stage false evidences to charge our client and Mummy Amen through biased and concocted police investigated by which they intend to wrongly convict and to jail our Client and Mummy Amen while he takes over the control and management of the said Estate. In order to scale this plan through, he connived and arranged with some of the above mentioned Police Officers and promised them houses in Amen Estate when the plot is successfully executed and the Officers have been able falsely played their role to pervert the cause of Justice through the concocted police investigation report.

Having observed his plot from the beginning of the said investigation, our client protested and wrote to both the Inspector General of Police and Deputy Inspector General of Police, Force Criminal Investigation and Intelligence Department (FCIID) about the bias and goal of the said officers assigned to investigate the matter wherein the said Police Officers where the one arranging Lawyers for the complainant in a matter they are just to investigate and thereby making the officers a party rather than an investigator.

That all the protest letters were being blocked by one CSP Muyiwa Adejobi through his influences as the Force PRO all in the promise of houses at Amen Estate if our clients were successfully prosecuted. It is more alarming to realize that this same planner has a collaborator in the Attorney General of Lagos State Office to finalize the job by ensuring that the State charge our Clients to court through the office of Director of Public Prosecution.

It may interest you to note that, there are two conflicting police investigating reports emanating from the same department in their bid to falsely prosecute our Client, the report sent to your office is different from the report attached to their response to the Fundamental Rights Enforcement Application before the Federal High Court.

In the light of the foregoing, we thought it worthwhile to notify the Hon. Attorney General and Commissioner for Justice of Lagos State of the Plot so as for the offices not to be innocently used to executed the planned malicious prosecution of our clients. Thus, a detailed analysis and explanations of the situation with compelling and overwhelming evidences were attached to the said Appeal letter to the AG. We hereby appeal to your prestigious offices not to be innocently used by these aggressive personalities to perfect their orchestrated plot of Babatunde Olalere Gbadamosi (BOG) to maliciously prosecute our clients. Herewith attached is the said appeal letter for your kind perusal.

RE: SINISTER MOVE BY A DEFAMATION OF CHARACTER EXPERTS, ADEYINKA IGBINOBA, SPONSORED BY BABATUNDE OLAKERE GBADAMOSI (B O G) AND OTHERS TO USE THE ATTORNEY GENERAL'S OFFICE AND THE LIKELY INSTIGATION OF THE OFFICE OF DIRECTOR OF PUBLIC PROSECUTION (DPP) TO RELY ON BIASED AND DICTATED LACED POLICE INVESTIGATION REPORT MALICIOUSLY PADDED BY MUYIWA ADEJOBI THROUGH CSP EGWU AND ACP MUSA AND SP KOLAJO OGUNDILE OF THE IGP MONITORING UNIT TO LURE THE DPP TO FRAME UP FALSE CHARGE AND TO MALICIOUSLY PROSECUTE HON. SAHEED AUDULLAHI MOSADOLUWA (IBILE) AND MRS. FOLASADE BALOGUN (CEO AMEN ESTATE; ESTRANGED WIFE OF B.O.G). WITH B.O.G PROMISING EACH OF THE CONSPIRATORS HOUSES IN AMEN ESTATE ONCE THE OWNERS CAN BE SENT TO PRISON THROUGH MALICIOUS PROSECUTION.

COMPASIONATE PLEA TO THE ATTORNEY GENERAL OF LAGOS STATE TO DISCARD AND DISREGARD THE BIAS INVESTIGATION CONDUCTED BY SP KOLAJO OGUNDILE AND ACP MUSA AND THE POLICE INVESTIGATION REPORT THEREFORM BY CSP EGWU UNDER THE INFLUENCE OF CSP MUYIWA ADEJOBI FOR BEING EMPTY IN FACT AND FLACID IN EVIDENCE AND THE NEED TO EITHER NOT PROSECUTE OR ORDER FRESH INVESTIGATION BY WRITING THE OFFICE OF THE INSPECTOR GENERAL OF POLICE ASSIGNING THE CASE FILES TO AN UNBIAS TEAMS OF POLICE OFFICERS TO CONDUCT FRESH INVESTIGATION IRRESPECTIVE OF WHOSE OX IS GORED IN THE INTERST OF JUSTICE

THE ATTORNEY GENERAL'S OFFICE IS FOR ALL AND NOT FOR ANYBODY

The above subject matter refers.

We act as Solicitors to Hon. Saheed Audullahi Mosadoluwa (Ibile) hereinafter referred to as '**OUR CLIENT**' and on whose behalf and firm instructions we write your Good Offices. Our protest is simple, the IPO investigating the case confessed to the fact that Muyiwa Adejobi working with someone from the AG office who has been on the ACP Musa's neck to write an indicting report to the Attorney General of Lagos state Office in order to charge our client to court for Yinka Igbinoba being sponsored by Babatunde Olalere Gbadamosi (BOG) to assemble media personnel to defame and malign the person and character of our clients and more. The said Babatunde Olalere Gbadamosi confirmed himself as the chief planner of the whole plot in an audio conversation. The said audio conversation is hereby attached and marked Annexure A.

Kindly take note that Yinka Igbinoba and Babatunde Gbadamosi choose not to hide their relationship with Mr. Moyosore Onigbajo and one Bola Akinsete during #Drkemiolunloyo Twitter Space on how the plans to frivolously dock our clients was arranged with the Attorney General of Lagos State that he is just waiting for the police report to instruct one Dr. Martins of DPP to charge our client to court on frivolous police report and it is well documented during the program on Dr. OLUKEMI OLUNLOYO TWITTER SPACE in which we have filed 3 different suits in Federal High Court requesting unbiased investigation not from the officers who are parties to the complaints and in which one of them actually leaked all the secret and plans to our clients for the past 4 months. The suits are namely:

Though, we actually do not believe the caliber of the AG office will fall for the campaigns of promising police officers' house inside Amen Estate once our clients got arraigned in court in which Adeyinka Igbinoba and Kemi Olunloyo boasted that the AG has spoken to even the Magistrate before whom our client is to be arraigned not to release our clients on bail.

We wish to call the attention of the Honorable Attorney General of Lagos State and also the Commissioner for Justice to the malicious and vexatious defamation of our client's characters by ADEYINKA IGBINNOBA and others who have been sued and served with the Court processes and the malicious plan of Adeyinka Igbinnoba and her sponsors; Babatunde Gbadamosi (BOG) who is a two time People Democratic Party's Aspirant as the Party Gubernatorial flag bearer of Lagos State in both 2011 and 2015, in which Adeyinka Igbinnoba who is the complainant in the allegation of fraud and attempted murder against our client and the C.E.O of Amen Estate, Ibeju-Lekki which is being sponsored by Babatunde Olalere Gbadamosi (BOG) and their collaborators in the police who have jointly planned to procure a doctored police investigation report through the bad eggs in the police uniform to mislead the prestigious office of the Director of Public Prosecution (DPP) through the Attorney General of Lagos State's office to frame charges, dock and prosecute our client and one Ms. Folasade Balogun on a flabby, flaccid, frivolous, fallacious, concocted allegations of Fraud, Assault and Attempted Murder which were neither substantiated with any parol or documentary evidence nor allowed to be investigated by unbiased police officers or Teams.

The said arrangement with Police for a doctored report to dock our client is contained in the above annexed audio evidence and also his chat with a Police Officer on the 6th day of April 2022 where he chatted the Police Officer that his ex-wife and our client are behind counter at Alagbon and requested the said officer to take photographs of them in the cells to enable him publish same to further defame, humiliate and degrade the person of our client. Attached here with is the said printed chat and marked **Annexure B**.

We are not unaware of the fact that they have also secure the consent of some staff in the office of the Attorney General office by writing to pressurize the Police Legal Department through one CSP Egwu with the influence of CSP Muiyiwa Adejobi to send the doctored police investigation report to the AG's office to start prosecuting a case

without evidence of fraud or alleged bodily injury wherein they were only relying on a surgery video evidence in which our clients are not the Doctor that operated the legs and also not in the know of what led to the surgery in the private hospital that issued a report.

It is quite disheartening that the complainant (Adeyinka Igbinnoba) had boasted severally of her closest intimacy with high-ranking Police Officers and have had Pre-knowledge of the outcome of the investigation report even when the purported investigation by SP Kolajo Ogundile and ACP Musa who both ask our clients to go and know the interest of the AG office in Lagos in the matter. SP Kola and ACP Musa confirmed to our clients that they are working under instruction of a superior officer working hands in hand with someone from Lagos AG office and they want them to just have a report that may not succeed in court but at least to be in court for arraignment alone with the aim of cyber-bullying our clients.

It is unequivocal from the voice note of Babatunde Gbadamosi (herewith attached) that they have settled the case with the IPO, SP Kola Ogundile, CSP Muyiwa Adejobi and some other high ranking police officers where the mentioning Attorney General of Lagos State came to play in a wide publication, twitter space which we find very hard to believe that the Complainants and her sponsors boasted that the Police Investigation Report would be proffered to indict our client and one Ms. Folasade Balogun (Mummy Amen), and that it's been arranged that the report will then be sent to the DPP through whom the Attorney-General of Lagos State will penetrate to ensure that our Client and Ms. Folasade Balogun (who is the ex-wife of the sponsor of the whole plot) are docked, prosecuted and imprisoned. He further alleged that they have even perfected their assignment to send our client and Mummy Amen to jail with a judge.

Sir, it is embarrassing that the officers of law - who belong to all - were doing the bids of Tunde Gbadamosi (ex-husband of Mrs. Folasade Balogun) who is bitter about the divorced case and Adeyinka Igbinnoba (former realtor agent of Ms. Folasade Balogun) who are

everywhere promising the officers and also someone in the AG's office free apartment in AMEN ESTATE if they help him to jail our client and his ex-wife, Mrs. Folasade Balogun, for him to successfully takeover the AMEN ESTATE which is the sole property of the said Mrs. Folasade Gbadamosi. In his several attempt to engage several persons to help plant evidences in the Media for the blackmail of our client and Ms. Folasade Balogun, his plot got busted and the evidence is hereby attached and marked Annexure 'C' Series.

Sir, this is the motive behind Tunde Gbadamosi's plot and connivance with Adeyinka Igbinnoba to frame up our client and Mrs. Folasade Balogun and tricked the officers of law with fraudulent promises to secure doctored police investigation report through which they can deceive and mislead the office of Director of Public Prosecution through the Attorney General of Police to maliciously prosecute our client and Mrs. Folasade Balogun on wrongful, concocted and unsubstantiated allegations (majorly based on assumptions). We urge your good office not to be so deceived, tricked or innocently fall for their gimmick and malicious motives to use your office to persecute our client and Mrs. Folasade Balogun who are innocent businessmen of reputable, unquestionable, irreproachable characters.

Be informed further that Tunde Gbadamosi is the master plotter who used Adeyinka Igbinnoba to trap or frame up our Client and Mrs. Folasade Balogun, deceived police officers and also someone in your office with promises to dash each of them apartment in Amen Estate once he (Tunde) takes it over from his ex-wife, Folasade Balogun), utterly deceived with canvassed gender (feminine) sentiment aiming to incite public hatred for our client and Mrs. Folasade Balogun through defamatory publications and continuous cyberstalking and cyberbullying on different social handles and media, to denigrate and lower the integrity and reputations of our client and Mummy Amen. We shall rely on voice note of Tunde Gbadamosi confession.

Simpliciter, it was a well-rehearsed 30 million Naira Fraud and Attempted Murder complaint which is a mere off shoot of the case

of breach of agreement to purchase land from our client, to which Adeyinka and others libel (Defamation), cyberstalk and cyberbully, give false information to the office of the Attorney-General office who unknowingly wrote on behalf of Yinka Igbinoba sponsored by Tunde Gbadamosi to Nigeria Police Force to investigate but instead of investigating -they jointly planned to incarcerate/imprison our client and Mummy Amen, so as to fraudulently takeover Mummy Amen's properties, specifically 'the Amen Estate'.

When we noticed that SP Kolajo Ogundile has compromised his duty as a Police Officer to satisfy the bids of the Adeyinka Igbinoba and Tunde Gbadamosi, we have written several protest letters to the Honorable Inspector General of Police and/or DIG to escalate the fraudulent and bias mind of the Investigating Officer and requesting that the case be investigated by another set of police officers (or department) who are un-bias and who shall investigate the matter with all fairness to all the parties rather than Kolajo Ogundile and others such as CSP Muyiwa Adejobi and one CSP Egwu who Tunde Gbadamosi alleged have agreed with them to ensure that our client is prosecuted in Lagos State and imprisoned.

When it was obvious that SP Kolajo Ogundile and his co-conspirator in police uniform are seriously determined to imprison our client instead of conducting fair and bias-free investigation, we filed several lawsuits processes to compel the Nigeria Police to retrieve the file from Kolajo Ogundile and allow another police officer to investigate same irrespective of whose ox is gored. A copy of the said court process including the suits for defamation of our client's reputation which have all been served on them are herewith attached for your consideration. The said processes are marked **Annexure 'D'**.

Sir, our serious contention is that the ACP Musa led investigation report by SP Kolajo Ogundile (who is also a conspirator) is replete and influenced with bias, self-foster interest, acts of unprofessionalism orchestrated by greediness. The report finally written by CSP Egwu of the Legal Department of the Nigeria police Force is devoid of fair

investigation and thus, the case needs to be re-investigated by unbiased police officers for your prestigious office to be rightly guided. Having observed the sinister moves of the Officers as a result of the promises they have had, we petitioned the DIG FCIID and the IG that the matter be investigated by a fresh and unbiased Police Team but all to no avail as CSP Muyiwa Adejobi used his influence as the Force PRO to stall all our petition and protest letter from being investigated. Attached here with are copies of the said Petitions and Protest letters and marked **Annexure 'E' series**.

We deem it expedient to elucidate that Tunde Gbadamosi (BOG) was once a friend, and ex-husband of Folasade Gbadamosi (Mummy Amen) who is our client's mentor and business partners who our client learnt building development business from now and till tomorrow, mummy has been a blessing and supporting hands to his business through knowledge sharing and construction equipment in which Tunde Gbadamosi was not happy with after his bitter divorce with his ex-wife and he called our client to assist him to frame the wife up by planting an evidence in her Estate with promise of 10 houses in the ex-wife's Estate. Turning him down made our client his enemy despite all our client's effort to settle their differences and Tunde Gbadamosi now engaged Biodun Abdul and Adeyinka Igbinnoba to set our client and his ex-wife up for malicious prosecution, to further defame their characters and de-market our client's business.

It happened that sometimes in 2021, BIODUN ABDUL who is a sister to Adeyinka Igbinnoba approached our client's company through Kola Opeodu who happened to be one of Babatunde Gbadamosi (BOG) political tout on purchase of land, in which they agreed for N120,000,000.00 (One Hundred and Twenty Million Naira) and Biodun Abdul did her due diligence after which she committed herself to the purchase with N30,000,000.00 (Thirty Million Naira) with pledge of paying balance within 2 weeks not knowing she is not ready to buy land but to frame him up while he is not even aware that the BIODUN ABDUL who is a sister to Adeyinka Igbinnoba knows Babatunde Gbadamosi (BOG) or Folasade

Balogun. Within 48 hours of the first payment, Biodun Abdul and Adeyinka Igbinnoba started calling our client for refund with a claim that the Certificate of Occupancy which is the title of our client's land is forged and that Land Bureau at Alausa informed them that the Certificate of Occupancy is about to be revoked in which our client demanded Land Bureau official report confirming to the fact that the land is not genuine and 4 days later they have written petition against our client to the Economic and Financial Crime Commission (EFCC) for fraud and all that.

At that point, our client did not know that it was a well-rehearsed drama with Babatunde Olalere Gbadamosi (BOG) conspiring with Biodun Abdul and Adeyinka Igbinnoba. He went to the land section of the Economic and Financial Crime Commission (EFCC) in Ikoyi to disseminate Biodun Abdul frivolous petition and based on the facts with evidences used in responding to Biodun Abdul and Adeyinka Igbinnoba's false accusation, the Economic and Financial Crime Commission (EFCC) then released our client on self-recognition to come back in a month for the Commission to investigate the Certificate of Occupancy from Lagos State Land Bureau as he demanded from the Economic and Financial Crime Commission to investigate and also prosecute the false information.

On leaving the Economic and Financial Crime Commission, an elderly woman called him on phone claiming to be a mother to Biodun Abdul that reported me to Economic and Financial Crime Commission, not knowing she is also working for Babatunde Olalere Gbadamosi (BOG) to frame him (our client) and Mummy Amen, she demanded for a meeting with him, unknown to him she is to organize for another stage of their frame-up game since the fraud allegation at Economic and Financial Crime Commission (EFCC) has failed, he agreed to meet with her by 20th November, 2021 in which she came with Biodun Abdul, Olubunmi Okoror and Adeyinka Igbinnoba to see him in his office, immediately they got access to his office, the Mrs. Olushola Abdul Beckley who claimed to be a mother to Olobunmi Okoror, Adeyinka Igbinnoba and Biodun Abdul started conversation with provocative language like "where is the money,

you duped my children, do not push me to use my influence in media and Lagos State Ministry of Justice to fight you. Our client smiled and told her it is mere business transaction, if she wants refund, her daughter should go and withdrawal her petition at Economic and Financial Crime Commission and for her to note that we would charge 25% administrative charges.

At that point Adeyinka Igbinnoba said, she want to say something, our client permitted her, and all she could say is Mr. Saheed, "you are a proud person" when he noticed her taking his picture inside his office, after all sort of insult from her, he asked her to leave his office and she said "I am not fucking leaving anywhere" and our client walked out of his office while he left them inside his office making noise, and under 5 minutes she also walked out and left with Olubunmi Okoror while the Mrs. Olushola Abdul Beckley and Biodun Abdul were still waiting in our client's office, he went back to his office and the Olushola Beckley who is old enough to be our client's grandmother pretending as if she want to kneel down for him, he was shocked and said mummy give me your Account, and immediately he transferred N15,000,000.00 (Fifteen Million Naira) to her account with understanding that she is going to withdraw their frivolous petition at the Economic and Financial Crime Commission (EFCC) while he did not know that they are just playing Babatunde Olalere Gbadamosi's script to set our client and Folasade Balogun up for houses in Amen Estate as he has been promising some bad eggs in Police Force in which our client and Mummy Amen do not know what he might promise his contact in Attorney General of Lagos State and the Directorate of Public Prosecution Office.

Sir, at the moments our client was seeing their mother off to her vehicle after about 45 minutes that Adeyinka Igbinnoba and Biodun Okoror had our client's office, someone called Biodun Abdul on phone and she said '**Mummy won ni omo yin ti ni accident**' (my mum, they said your daughter had an accident)' and when our client asked her who, the mother replied, '**my daughter that just left here**'. On humanity, Our client drove behind the mother to the hospital they claimed Adeyinka

Igbinnoba was rushed to, but on getting there they claimed she has been discharged and her husband would not allow us to see her, our client then left for his house, within 2 hours, the mother called on phone claiming that our client shattered her daughter's legs, it down on our client that guessed right that they were sent to frame him up but he did not initially know by who, different invitation flied in from Ajah Police Station, Pantl and Alagbon Police Command as superior office to the other 2 invitation.

On getting there, he was accused of fraud and attempted murder in which Biodun Abdul, Olubunmi Okoro and their mother claimed in their statement that they have video of our client shattering Adeyinka Igbinnoba's legs and her driver also said the same thing but on request by the DCP Ogundele that they should provide the evidence as claimed in their statement, she provided surgery video in which the DCP said something led to the surgery, that he need to see video of our client shattering Adeyinka Igbinnoba's legs as she claimed, Adeyinka said she can only produce the evidence in Court in which the DCP Ogundele of the General Investigation, Alagbon said "there is much to their case" they are not ready to share with Police that he cannot charge our client to Court in a case they cannot provide evidence for and he is not going to send any file to the Directorate of Public Prosecution as requested by Adeyinka Igbinnoba because there is no case if there is no evidence of bodily arm injury. They collided with the DC Pantl who also happened to be their friend to facilitate another petition to his office in which he sent his men to harass our client's family by telling his children that they are looking for him for a case of armed robbery, arrested his mechanic, detained him at Pantl for 3 days claiming he is a soft target to arrest our client.

Our further findings revealed that a letter emanated from the Office of the Attorney General to Deputy Commissioner of Police at the State Criminal Investigation Department, Pantl, Lagos State where it was alleged that our client was invited n several occasion and he did not show up which is a blatant lie that cannot stand the test of time as our client did not receive any invitation from the Office of the Attorney General

of Lagos State regarding the above captioned matter at period of time. More importantly, during our interview with the DC, Panti, the IPO in charge of the matter lied to the DC that they have invited our client on several occasion but upon cross examination of the IPO in the presence of our client, the IPO made it known that they did not invite our client but based their judgement on what the Complainant had said about our client that he will not honor the invitation and as such, they issued warrant of arrest against our client without any prior invitation or investigation.

On seeing that their Plot at the State CID is not materializing either, Adeyinka Igbinnoba and Babatunde Gbadamosi and whoever's influence they are using at AG could not achieve their aim through Alagbon, they lodged complaint against DCP Ogundele to kill the investigation report which has confirmed that Adeyinka Igbinnoba, Biodun Abdul and their mother gave police false information on fraud and attempted murder and their complaint was addressed to Inspector General of Police with the aid and help of DCP Muyiwa Adejobi and the Principal Staff Office to the IGP, those whom might have innocently fallen for gender sentiment facilitated her frivolous petition to be assigned to one Mr. Kola Ogundile with clear instruction to take over the file from Alagbon to arrest our client and Mummy Amen to be detained in Panti. And also write a report to indict our client and mummy Amen and then send the said report to the Office of Attorney General of Lagos State for our client to be docked, tried and jailed as confessed by Adeyinka Igbinnoba on Kemi Olunloyo's Twitter space where they assembled 214 media practitioners to achieve their goal of defamation of character, libel, cyberstalking wherein, Adeyinka Igbinnoba and Babatunde Gbadamosi finally declared our client and Mummy Amen wanted on social media while the name of the Lagos State Attorney General was constantly in the air by Adeyinka Igbinnoba and Dr. Kemi Olunloyo as someone who they have already concluded the arrangement with. Attached herewith are the Media sponsor of Babatunde Gbadamosi through his cronies and Adeyinka Igbinnoba and marked **Annexure 'F' Series**.

Also attached is Babatunde Gbadamosi voice note, the 3 hours Twitters Space audio where she confessed all to have perfected the arrangement with the AG of Lagos State, Mr. Moyosore Onigbanjo SAN and Muyiwa Adejobi and how the Investigative Police Officer arranged team of lawyers for her to negotiate N500,000,000.00 (Five Hundred Million Naira) as compensation for her as condition for Mummy Amen bail and she claimed she has the video of how they shattered her leg on cloud but not produce it to our client's surprise. SP. Kola Ogundile wrote a frivolous police report in which whoever they are using his influence in AG or DPP 's Office has been pressuring the CP Legal to give them the file to file their frivolous charges in Lagos State either succeed or not, they will at least achieve media trial, and false remand in prison for Babatunde Gbadamosi to take over his ex-wife Estates.

The IPO wrote to the Land Bureau to confirm the Genuity of the land and they confirmed the Genuity of the land, they look away from the fact that Adeyinka Igbinnoba gave false information of fraud and the IPO later called our client that because of Mr. Muyiwa Adejobi and PSO 1 at IGP office are pressuring him to give him slight charges and also arrange a magistrate for him to give him bail, through the DPP, knowing Mr. Kola Work for Babatunde Gbadamosi in the attached audio of Babatunde Gbadamosi and one Samuel confessing how he arranged with the Police in Abuja to imprison our client and Mummy Amen through the office of Attorney General of Lagos State.

Sir, the Investigating Police Officer (IPO), SP Kolajo Ogundile was so shameless and somersaulted in his duty to investigate the matter without bias, when he arranged lawyers for Adeyinka Igbinnoba to negotiate N500,000,000 from our client claiming that they have seen how much our client has in his account, to extort him and Mummy Amen. However, when our client insisted that he wants and only interested in thorough un-bias investigation of the case by an unbiased team, the IPO forcefully collected the sum of N20,000,000 from our client and fraudulently and forcefully collected another N1,000,000 from our client for Adeyinka's lawyer. These monies were forcefully collected by

the IPO, SP. Kolajo Ogundile by trick and threat not to release Mummy Amen from police custody unless the money is paid. Attached herewith are the evidences of the monies paid into the personal Account of the IPO, the instruction that followed the money and the Lawyer he provided for Adeyinka Igbinnoba for your kind perusal and marked **Annexure 'G' series**.

This IPO's unprofessionalism was confirmed by Adeyinka Igbinnoba who stated in his Twitter Space discuss with Kemi Olunloyo that the IPO, SP Kolajo Ogundile arranged lawyers for her, collected monies from our client for her and for her lawyers, and that Saheed will soon be charged to Court in Lagos. It is more absurd that the said Dr. Kemi Olunloyo went ahead on her instagram page to declare our client and Ms. Folasade Balogun **'WANTED CRIMINAL'** and other defaming wording on her Twitter page. Attached herewith are the said declaration and publication for your kind perusal and marked **Annexure 'H' Series**.

Thus, it is our client's sincere protest that the investigation purportedly conducted on this case by the ACP Musa team led by SP Kolajo Ogundile is fraudulent, scam, utterly influenced with bias, gender sentiment and selfish personal foster interest of the IPO and his cohorts, and as such the Report emanated therefrom is a strong attempt to mislead the reputable office of DPP to get our Client and Mummy Amen maliciously prosecuted.

We are not unknown that the AG has unfettered power to ensure that justice is done to all the parties and to avoid being used by rogues to achieve their fraudulent goals.

Sir, it is settled that Justice is not one way traffic, it is three ways traffic - **justice to the victim, justice to the defendant and justice to the society (the complainant)**. It could be gleaned from the foregoing that the Investigation conducted by SP. Kolajo Ogundile and the report from CSP Egwu therefrom is only to satisfy the bids of Adeyinka Igbinnoba and Babatunde Gbadamosi who bought the concocted report with millions, promises and gender sentiment from the

Police at the expense of Justice and Liberty of our Client. The investigation was not fair at all and the report was obtained by fraud.

On a concluding note, we are not unaware of the fact that the said concocted investigation report has been sent to your honorary office for consideration and to determine the next line of action as such, we pray you to discard such concocted report that were purchased with Million as it cannot stand the test of time as we have established here with the attached documents and evidences that this is a plot by Babatunde Badamosi to get at our client and his ex-wife to hijack her Amen Estate at Eleko Beach Road, Ibeju Lekki Local Government Area of Lagos State with load of promises to his conspirators.

In view of the above, we shall be urging the Honorable Attorney General of Lagos State Director of Public Prosecution to use your power and discretion to ensure all the parties Ogundile andy discarding and disregarding the Police Investigation Report emanated from the purported investigation conducted by SP Kolajo Ogundile, and **order the re-investigation of this matter in the sole interest of justice because our client will be unjustly prejudiced if the instant Report is considered by the honorable DPP.**

Our client and Mummy Amen are ready to be investigated but any report from ACP Musa of IGP Monitoring Units and Akin Ogundile and CSP Egwu of the CP Legal and charges to be prepared by the agents of Babatunde Gbadamosi in Lagos State DPP who is currently in Abuja distributing Millions to bad eggs in Police service to have frivolous report as instrument in charging me and Mummy Amen to court for Babatunde Gbadamosi to hijack her ex-wife Estate.

We will humbly appreciate your urgent attention to be attached to this letter to avoid being misled and further dragging of our innocent client and that of mummy Amen by the concocted Report influenced by gender sentiment, personal foster interest of bad eggs in police uniform including the IPO etc.
